

Auto Pay Contract

Terms and Conditions:

- I authorise CrossFit Plus to process a direct debit from my designated account, on either a weekly, fortnightly or monthly basis, according to my agreed contract.
- I agree to either a 6 or 12-month minimum-term, with no hold period in that term, unless you are on the "flexi plan".
- I understand that the *AutoPay* contract allows me to either attend unlimited or 3 x per week CrossFit Plus Classes, excluding special events and workshops.

Fees:

- I acknowledge that the additional bank account transaction fee/s will be incurred by me.
 - Total on-going fees will include the selected membership fee (as per rates page on the website) with an additional:
 - Bank transactions fee: \$1.25* (**fees are charged per transaction*)

 - Master card/Visa 2.2% of debit membership amount
 - Diners/AMEX 4.4% of debit membership amount
 - Dishonor payments: \$9.90 (in addition to any bank dishonor fees you have agreed to with your normal bank)

Auto Renew:

- Once the 6 or 12month term is complete, the *Autopay* contract will continue on my nominated debit cycle until I notify CrossFit Plus otherwise.
- If you choose at this point to cease or hold your contract, upon return you will be required to sign a new contract for a set period.

Termination of Contract:

- I acknowledge that contracts terminated before the contract period is completed up will incur an extra charge of \$99.
- I acknowledge that 2 weeks (14 days) notice of termination of contract must be given to CrossFit Plus by email to info@crossfitplus.com

- I acknowledge that there are no refunds or exchanges once a payment has been processed.

Payment Default:

- I acknowledge that if my credit card or bank account fails to authorise the debit amount for any reason, I have 7 days to provide funds, or update details, otherwise a \$15 late fee will apply (in addition to any incurred dishonor fees).

- I acknowledge that my *Autopay* service will be deactivated if my account becomes more than 30 days in arrears.

Holding AutoPay:

- I acknowledge that I may put *AutoPay* on hold once per year with no fee for a maximum of two weeks.
- If you choose to place your contract on hold for longer than a two week period, you will have to terminate your contract and re-sign a new contract upon return (this will incur termination fees and charges).
- I acknowledge that a minimum of 2 weeks (14 days) notice must be given in order to hold my *AutoPay* debit. Notification must be by email. For more details call 0439 339 422 or info@crossfitplus.com
